

TELMEX USA MISCELLANEOUS CHARGES, CREDITS, FEES, SURCHARGES, AND TAXES [Revised Title]

As of May 18, 2006

Some or all of the charges listed below may apply on a customer's invoice and are in addition to all other rates and charges.

Property Tax Fee

Revised May 1, 2010

A Property Tax Fee will be applied to all interstate and international charges, subject to billing capability. The property tax fee is a monthly charge which recovers amounts paid to state and local governments and to our underlying carriers. This fee is equal to your interstate, international and unregulated services multiplied by 2.3%, subject to billing capability. This fee is not subject to any discounts. Customers who have submitted tax exempt forms are not excluded from this fee. Unregulated services could include enhanced services (such as internet access) and charges for co-location, dark fiber, etc.

Universal Service Charge

Revised May 1, 2010

The Universal Service Charge ("USC") is a non-discountable monthly charge based on the FCC prescribed quarterly universal service contribution rate. The universal service charge mirrors the rate set by the FCC in effect as of the bill date. Charges for communications or transmissions between two points outside the United States are not subject to this charge. Cost Recovery Fee

Revised May 1, 2010

The Cost Recovery Fee is a monthly charge of 3.1% applied to interstate, international and unregulated services, subject to billing capability. This fee is not subject to any discounts. This fee recovers regulatory fees and other expenses incurred by Telmex USA such as FCC regulatory fees, federal regulatory fees to fund programs, various State Public Utilities Commission (PUC) fees, various state business licenses, and various state annual regulatory fees.

Gross Receipts Surcharge

Revised May 1, 2010

When utility or telecommunications assessments, franchise fees, privilege, license, occupational, excise, or other similar taxes or fees, based on interstate receipts or assets are imposed by certain taxing jurisdictions upon Telmex USA or passed on to Telmex USA through or with access and other charges from its underlying or interconnecting carriers, the amounts of such taxes or fees will be billed to Customers in such a taxing jurisdiction on a prorated basis. The Gross Receipts Surcharge applicable to Customer for a given taxing jurisdiction is equal to the applicable Tax Factor (as set forth in the Gross Receipts Tax Surcharge Table), multiplied by the net charges for the services subject to such taxes or fees provided to and billed to each Customer Site in such a taxing jurisdiction. The bill display name for the Gross Receipts Surcharge may vary from state to state.

Payphone Surcharge

An un-discountable Payphone Surcharge of up to \$0.99 per call shall apply to each coinless call originating from a domestic Public or Semi-Public Payphone including but not limited to calls to a Customer Toll-Free Number or to an access code.

South Carolina Universal Service Charge

This is a charge to support universal service in South Carolina. The South Carolina Universal Service Charge is prescribed by the Public Service Commission of South Carolina. This charge is a percentage of the intrastate, interstate, and international charges for Services within the state of South Carolina of customers whose service address is in South Carolina. The South Carolina Universal Service Charge is not subject to any waiver or exemption.

Other Fees and Surcharges

Revised May 1, 2010

Telmex USA may assess other surcharges to recover amounts Telmex USA is required to pay in support of statutory or regulatory programs including but not limited to state specific universal service funds, mandated user fees, telecommunications and deaf relay charges, and other federal and state miscellaneous charges as well as excise, sales, use, gross receipts, or other similar taxes levied by a governing body on Telmex USA. The rates for some of these

surcharges, taxes, and fees are set by the governing bodies while others are set by Telmex USA in accordance with the amounts it must pay to the governing bodies. Where required by state law, amounts of these surcharges are set forth in Telmex USA's in-state tariffs.
